## REGULAR SESSION 7:00 P.M.

The Board of School Trustees of the Rensselaer Central Schools Corporation met in Regular Session on Tuesday, May 17, 2016 at the Rensselaer Central Schools Corporation Administrative Offices Board Conference Room. Board Members present were Charlie Parrish, Earl Zeider, Rich Ludington, Julie Koczan, Brad Cozza and Ed Lane. Ed Korniak was absent.

President Ludington called the meeting to order at 7:00 p.m.

President Ludington determined a quorum present.

The Pledge of Allegiance was recited by all.
