## **REGULAR SESSION**

The Board of School Trustees of the Rensselaer Central Schools Corporation met in Regular Session on Tuesday, April 19, 2022 at the Rensselaer Central Schools Corporation Administrative Offices Board Conference Room. Board Members present were Janice Deno, Gary Braasch, Charlie Parrish, Kevin Armold, Rick Odle and Mark Jordan. Emily Lyons was absent.

President Parrish called the meeting to order at 7:00 p.m.

President Parrish determined a quorum present.

The Pledge of Allegiance was recited by all.

President Parrish stated that there were three (3) additions to the agenda, Item J.17–Approval to Declare Old Desks and Chairs as Surplus Equipment, Item K.4 – Approval of Bobbi Jo Sammons as Summer IREAD 3 Teacher and New Business – Appointment to Jasper County Library Board. Mr. Jordan made a motion to approve the amended agenda. Mr. Odle seconded the motion and the vote of the board was unanimous in favor of the motion.

The minutes of the March 15, 2022 Regular Session were presented for board approval. Mr. Armold made the motion to approve the minutes as presented. Mrs. Deno seconded the motion and the vote of the board was unanimous in favor of the motion.

Superintendent Craig presented slides of the work being done on the pool and of the Middle School boilers. The new High School chiller is still on back order. Instead of renting a chiller until the new one arrives, the project may have to be pushed back until after the season, this fall. Roof supplies arrived and the project is on schedule.
